DIRECTIONS:

From Erie: (1) Take I-79 South to Edinboro Exit #166. (2) Turn left and follow State Route 6N into town of Edinboro. (3) Turn right onto Route 99 at main light in downtown Edinboro. (4) Follow Route 99 into Cambridge Springs, PA. (5) Turn left at stop sign onto McClellan Street. (6) Turn right at light onto State Route 19 (aka North Main St.). (7) Veer right after crossing bridge and follow State Route 19 (now Venango Avenue). You'll see school on the left.

From Buffalo: Follow I-90 South. Take I-79 South to Exit #166. Follow "From Erie" directions starting with step number 2.

From Cleveland: Follow I-90 East towards Erie, PA. Take I-79 South to Edinboro Exit #166. Follow "From Erie" directions starting with step number 2.

From Pittsburgh: Take I-79 North to Exit #166. Turn right at end of exit and follow State Route 6N into town of Edinboro. Follow "From Erie" directions starting with step number 3.
