Merge onto NY-204 E via EXIT 6 toward AIRPORT
Turn LEFT onto NY-204 E / NY-33A E / CHILI AVE.
Turn SLIGHT RIGHT onto BROOKS AVE / NY-204 E.

End at **911 Brooks Ave**

From Syracuse

Merge onto I-690 W.
Merge onto I-90 W / NEW YORK STATE THRUWAY W via EXIT 1 toward BUFFALO
Merge onto I-390 N via EXIT 46 toward ROCHESTER
Take the BROOKS AVE EAST exit- EXIT 18A.
Turn RIGHT onto BROOKS AVE / NY-204.
